3. The nominee must be an Antioch Chamber of Commerce member for at least 2 years and in business for 3 years or more.
4. Reviewing and Selection Committee members’ businesses are not eligible.
5. All nominations must be in writing, including information to support the nomination, be signed by the person or organization making the nomination and include the nominator’s address, phone number and email address.
