Exhibitor Agreement

The Antioch Business Expo Exhibitor agrees to each and all clauses set forth in this agreement: Exhibitor agrees to hold harmless the Antioch Chamber of Commerce, City of Antioch and any and all sponsors, employees or volunteers against loss, damage or injury while attending or participating at the Antioch Business Expo at 4703 Lone Tree Way Antioch CA 94531

- 1. The Antioch Chamber of Commerce agrees to supply each Exhibitor of the Business Expo with services outlined in the Exhibitor Agreement. A table with 2 chairs will be provided for all Exhibitors that have booth or vendor space. Any other pieces of equipment that will be used in the exhibitor booth must be provided by the company and pre-approved by the Antioch Chamber.
- 2. All exhibitors are expected to have 1) table linens, 2) presentation materials, 3) name tags, 4) business cards, 5) company approved promo items, 6) necessary office supplies (i.e. pens, notepads, paperclips, rubber bands, tape, etc., 7) signage
- 3. The exhibitor space provided must be occupied by a representative of the company at all times during the event. The company representative is solely responsible for their property and security of anything brought into the Business Expo.
- 4. Banners to be hung at the event will be provided by the Exhibitor and must meet the following specifications:
 - a. Vinyl material with grommets not to exceed 3 feet tall by 6 feet wide.
 - b. The location of the banner will be at the sole discretion of the Antioch Chamber
- 5. Exhibitors and their guests may not hand out company information to other guests at the Business Expo except at their company vendor booth. Information is only to be distributed from vendor spaces.
- 6. Applications from prospective Exhibitors will be reviewed and may not be approved if your business type is not consistent with the expectations of the Business Expo Committee.
- 7. Signature pages must be mailed, emailed or submitted to the Chamber Office within 7 days of submitting payment. By signing, paying and submitting this application, the business owner certifies that the business is fully licensed, insured and bonded per necessary city, county, or state regulation bodies and may legally engaged in business practices or services. Business owners will be prepared to demonstrate credentialing if asked to provide.
- 8. Exhibitor and guests agree to allow photos to be taken of their products or services for promotional purposes.
- 9. No refunds will be given once a completed Application has been accepted and processed.
